INSTRUCTION TO AUTHORS

THE JOURNAL

IJEK (International Journal for Exchange of Knowledge) is an international biannual journal published by International Association for Exchange of Knowledge (IAEK). The journal is *online* and the articles can be downloaded by logging on the website <u>www.iaek.org</u>. It is a multidisciplinary, peer reviewed, open access journal.

AIM OF THE JOURNAL

The journal publishes original papers of all disciplines in the form of general article, research papers, short research communication, conference report, work experience, traditional knowledge, innovative ideas, research news and general correspondence. Reviews of books, theses, and research articles are also published.

SUBMISSION OF MANUSCRIPT

Only original research papers are considered for publication. The authors should declare that the manuscript has not been submitted to any other journal for publication and will not be sent to other journal when communicated to the IJEK until the rejection. The soft copy of the manuscript should be submitted online or by Email on: <u>drpcthakur@gmail.com</u>

FORMAT OF MANUSCRIPT

The manuscript must be written in English/Hindi and should be typed double spaced with 1 inch margin all the sides. The paper should have **title** (in capital, font size 14); **names of the authors** (in capital, font size 12) and **address of the institution** where the work was done. **PIN Code** and **Email ID** should also be included. Name of one author should be marked with * to designate as corresponding author. A short title and 3-5 key words/phrases should also be given.

Typing software – M. S word, Page Maker, Fonts – Times New Roman (size 12)/Kunt Dev (size 10), Figures and Photographs – Coloured, JPG

Research Paper

The paper should be divided into Abstract, Key words, Introduction, Materials and Methods, Result and Discussion (separate or together), Conclusion, Acknowledgements (if any), References and Legends. 'Introduction' should

give reason, aim and objective of the investigation. 'Materials and Methods' should give brief description of the materials undertaken and methods adopted. 'Results' should include observation of the experiment illustrated with tables and figures. 'Discussion' should correlate the finding with the research report of the other authors and draw the conclusion. Tables and figures should be sited sequentially. Word limit for whole manuscript should be (3000), abstract (200), Key words (3-5). Table and figures-5 **General Article** – Should not exceed 4000 words, Abstract – 300 words, Key words (3-5). Tables and Figures –6 and should be sited sequentially.

Review of Article, Book, Ph.D thesis etc. – Should not exceed 4500 words, Abstract – 300 words

Short research communication – Not more than 1500 words and 3 displays (tables & figures) to communicate new findings immediately and Key words (3-5). Tables and figures should be sited sequentially.

General Correspondence – Letters **n**ot more than 600 words about the previous articles published in this journal.

References at the end of the text should be listed in alphabetical order in the following format –

Ref. of authored book – **Thakur P C 2007.** *Environmental Studies*. A B D Publishers, Jaipur, India. P. 35

Ref. of edited book – **Bajaj Y P S (ed.) 1997.** *Biotechnology in Agriculture and Forestry.* **Vol. 40.** Springer-Verlag, Berlin, Heidelberg, pp.34-48

References in the text should be quoted by the author's last name and year in parentheses and presented in year order. When there are two authors; last name of both authors should be quoted. When there are more than two authors; the reference should be quoted as; first author followed by **et al.** When more than one paper of same author appears in the same year; say 2014; it should be distinguished by eg. 2014a & 2014b.

Standard abbreviations and units should be used. Abbreviations should be defined when it appears first in the text. Use of abbreviations should be avoided in the title and abstract. Generic names of chemicals should be used.

Reprints can be ordered at the time of acceptance of the article/ research paper.
